Explain: **The review area for this jurisdictional determination includes one roadside ditch labeled as Wet Ditch 1 on the attached figures labeled 2021-01374-BGOAJD Attachments, Pages 1-3 of 3. The total area of non-jurisdictional waters/features is approximately 0.05 acre.**

The roadside ditch was constructed in uplands to convey runoff from the adjacent roadway, drains only uplands, and does not carry a relatively permanent flow of water into waters of the U.S. (WoUS). This was confirmed by reviewing aerial photography, hydric soils, and national wetland and hydrography data provided in the delineation report. Per the Rapanos decision, the assessed ditch is not a WoUS because it is not a tributary and does not have a significant nexus to traditionally navigable waters.
