The delineation report contains aerial imagery from 1991-2020 that confirms that Area 1 has no surface connection to Parker Lake. The location Area 1 is located in and the surrounding areas are mapped in non-hydric soils as shown in the delineation. The soils maps, along with the lidar maps included in the delineation support that Area 1 is surrounded entirely by uplands. Area 1 meets the definition of a non-adjacent wetland and is not a water of the US (WOUS) under the NWPR.
