Ditch (W-2)	1,400	linear feet	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	W-2 meets the definition of a ditch because it is a constructed channel used to convey runoff, evidenced by aerial photos and ground level photos. USGS topographic maps and aerial photos show that the ditch does not relocate a tributary and is not constructed in a tributary. A portion of the ditch was constructed in hydric soils with evidence of historic wet signatures; however, the ditch carries no more than ephemeral flow, evidenced by aerial imagery and the delineation report showing a lack of flowing water in many years.
W-3	0.22	acre(s)	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	W-3 is a pond used to store stormwater runoff that was constructed sometime between 1996 and 2000. Historic aerial photos show wet signatures where the pond was constructed, and the soils are hydric according to the NRCS soil survey. However, wetland in this area is not jurisdictional because it is surrounded by upland and was not adjacent to an (a)(1)-(a)(3) water, evidenced by topography showing a natural depression and aerial photographs that do not show the wetland abutting an (a)(1)-(a)(3) water. Therefore, W-3 is excluded as a stormwater pond constructed in non-jurisdictional waters.
