Road Ditches 26-A (0.14 acre) and 26-B (0.08 acre) are man-made ditches constucted in uplands along Jamison Avenue. Information provided within the 2019 Wetland Delineation Reports indicate that the subject waterbodies do not have a relatively permanent flow of water, drain only uplands. Therefore, the waterbodies are not Waters of the United States per the preamble to 33 CFR (Code of Federal Regulations) Part 328 in the 13 November 1986, Federal Register (51 FR 41217, Section 328.2).





Figure 1 - Site Location





Figure 2 - Environmental Setting and Delineated Wetlands




Figure 3 - Delineated Wetlands and Topography







Figure 4 - Jamison Avenue Improvements Plan
