Explain: **The approximately 8.7-acre review area contains one intrastate wetland (Wetland 1) that is not a water of the U.S. This was confirmed by reviewing the Surface Water Data Viewer (SWDV), Ozaukee County aeriels and topographic map, the 2017 Baxter & Woodman wetland delineation report, and Google Earth aerial photographs. Wetland 1 is located in the southern portion of the review area and is mapped as an emergent/wet meadow wetland in the SWDV. No inlets or outlets to Wetland 1 are visible in any of the aerial or ground level photos reviewed. Wetland 1 is located approximately 430 feet away from the nearest mapped tributary, an unnamed tributary to the Milwaukee River.**

**Wetland 1 is isolated with no surface or shallow surface connection to jurisdictional waters. It is not bordering, neighboring or contiguous with another water of the U.S. and is not separated from other WOUS by man-made dikes, barriers, or berms. The surrounding land use is dominated by commercial and residential development. The disturbance of surrounding land uses precludes an ecological connection to a WOUS. Wetland 1 does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetland 1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
