Explain: **Wetlands 1 is an isolated wetland depression with no surface water connection to navigable waters. Based on a review of aerial photography and the wetland delineation report submitted by the requestor, we have determined that this feature is an isolated wetland depression with boundaries that transition into uplands. Review of Google Earth aerial imagery and figures submitted in the wetland delineation report do not show a surface water connection to a WoUS. The wetland outlined above does not support links to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. This wetland does not have an ecological connection to a water of the U.S. (WoUS). Furthermore, the area is hydrologically isolated with no surface water connections to a WoUS. Therefore, the Corps has determined Wetlands 1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
