Wetland Area 2	0.013	acre(s)	(b)(1) Non-adjacent wetland.	Wetland Area 2 is surrounded by uplands, is not abutting an a(1)-a(3) water, and is not separated from one by a natural or man-made feature. Wetland Area 2 is not flooded in a typical year by an a(1)-a(3) water.

C. Additional comments to support AJD: Wetland Area 1 is a degraded ditch with wetland areas developing alongside the original ditch location due to sedimentation and lack of maintenance. The ditch is connected to a stormwater pond with an outlet structure that leads to an intermittent stream. We have made the determination that the wetlands developing alongside Wetland Area 1 are adjacent to the excluded ditch and not the intermittent stream, satisfying the (b)(1) exclusion.
