Explain: **The review area for this AJD includes three aquatic resources, Wetland 1, Wetland 2 & Wetland 3. These wetlands are depressional basins located on a residential lot, vegetation in the wetlands consists of sedge, reed canary grass and woolgrass, and the wetlands are surrounded by upland grassland and forest. These wetlands do not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries. Based on review of historic and recent aerial photography, The National Wetland Inventory (NWI), USGS topographic maps, and the wetland delineation report submitted by the requestor, we have determined that Wetlands 1-3 are hydrologically isolated with no surface water connection to a water of the United States (WoUS). The wetlands are not located within a 100-year floodplain. The wetlands are surrounded by non-jurisdictional upland, and there are no swales, ditches, pipes, or other means that would provide a surface or subsurface connection to a WoUS. Wetlands 1-3 do not have an ecological connection to a WoUS.**

**Wetlands 1-3 do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and they are not known to be used for industrial purposes. Wetlands 1-3 are hydrologically and ecologically isolated and the Corps has determined that these wetlands are not regulated by the Corps under Section 404 of the Clean Water Act.**
