A review of available information including aerial imagery and the wetland delineation report indicate that these wetland features are situated within a roadside ditch, within the road right-of-way (ROW) of East Edgewood Drive/CTH JJ. Given the linear nature of these features and overall absence of wetlands within close proximity to the review area, it is likely that these ditches were created in uplands during the original construction of the roadway (exact construction date unknown). A review of the Wisconsin Wetland Inventory (WWI) shows no wetlands mapped within or immediately adjacent to the review area. However, aerial imagery (Google Earth) dating back to May of 1992 shows linear wetland signatures located within the road ROW. However, these features are limited to within the road ROW and do not extend to the south outside of the review area. USGS topographic maps indicate that surface water within the review area flows to the east towards Apple Creek which is located approximately 0.37 miles from the review area. As indicated Page 3 of the attached figures, there are culverts situated on the east and west ends of Wetland 1 and Wetland 2 which are likely used to convey surface water through the ditch towards Apple Creek. However, this roadside ditch does not have perennial or intermittent flow, and therefore does not meet the definition of an (a)(2) tributary.</p> <p>Based on this information, the Corps has determined that Wetland 1 and Wetland 2 are upland constructed roadside ditches which are (b)(5) excluded waters. Therefore, these features are not regulated by the Corps under Section 404 of the Clean Water Act.</p>

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
