 - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The aquatic resources that were assessed, Wetlands E, F, G, H, K, N, O, R and T, are located on a 57.1 acre property within the city of Nashwauk, Minnesota. These wetlands are small depressional basins that are surrounded by uplands and do not contain outlets. Precipitation flows from the surrounding uplands into the small basins where it pools and slowly infiltrates into the water table. They do not contribute a surface or shallow subsurface connection to Waters of the United States (WOUS).

We have reviewed available desktop resources such as aerial photography, LIDAR derived elevation models and contours, flow path information, and stream and wetland mapping to make an approved jurisdictional determination of the wetlands. We determined that the wetlands have no hydrologic or ecologic connection to a Navigable water of the U.S.

The aquatic resources within the review area are not known to be used by interstate or foreign travelers for recreation or other purposes; and are not known to be used for industrial purposes by industries in interstate commerce. The aquatic resources are either geographically isolated or uland ditches and do not support a link to interstate or foreign commerce. Therefore the resources in the review area, are not waters of the United States.
