Explain: **This AJD is limited to the boundaries of Wetland 5, as shown on the enclosed figures labeled MVP-2018-03533-SSC, Pages 1-2 of 2. Based on the wetland delineation report submitted by the requestor, aerial imagery, and LiDAR contours, we have determined that the wetland is isolated with boundaries that transition to uplands.**

Wetland 5 is a seasonally flooded wetland basin located centrally within the project site. The wetland delineation report provided 2-foot LiDAR contours of the site and shows that Wetland 5 is surrounded by upland. Google Earth imagery does not show a surface water connection to a water of the U.S. (WoUS). The wetland is not mapped on the National Wetland Inventory (NWI) and the National Hydrography Dataset (NHD) does not show a surface water connection to a WoUS.

Wetland 5 does not support links to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. This wetland does not have an ecological connection to a WoUS. Furthermore, the area is hydrologically isolated with no surface water connections to a WoUS. Therefore, the Corps has determined that Wetland 5 is not regulated by the Corps under Section 404 of the Clean Water Act.
