The AJD review area contains an approximately 1.79-acre sedimentation basin located at an existing landfill. A review of aerial photography indicates the sedimentation basin was constructed in 2008. A review of the Wisconsin Wetland Inventory and NRCS Web Soil Survey show the basin was not constructed in mapped wetlands or hydric soils. The AJD submittal indicates the sedimentation basin was constructed to store and treat surface runoff at the existing landfill. The 1.79 acre sedimentation basin is not a waters of the U.S. under the NWPR.
