			W-01 does not meet the definition of “adjacent wetlands”. A review of available information including the WWI, Google Earth, USGS Topo Mapping, etc., confirmed that this feature is an isolated wetland feature which does not maintain a surface water connection to an intermittent or perennial tributary. W-01 is situated in a non-hydric soil unit and is surrounded entirely by upland. Therefore, this wetland is physically removed from the nearest A(1)-A(3) water. There is no evidence that W-1 is directly abutting an A(1)-A(3) water. Based on this information, W-01 is hydrologically isolated and is therefore not regulated by the Corps under Section 404 of the Clean Water Act.
