Wetlands 2 and 3 appear to be fragments of an agricultural ditch previously abolished before 2015 and now exist in small depressional areas. Although wetland boundaries extend outside of the review areas, a review of aerial photos, site photos, and topographic maps indicate no connections are present to an (a)(1)-(a)(3) water. Wetland 3 abuts a man-made roadside ditch to the south however this ditch is not an (a)(1)-(a)(3) water and does not serve as a significant hydrological connection. The closest (a)(1)-(a)(3) water is an unnamed tributary approximately 0.63 mile to the east. All wetlands within the review areas are surrounded by uplands and not separated from this tributary by natural or man-made barriers and are not flooded by this tributary in a typical year. |
