 - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area contains one wetland labeled W-1. This wetland is not bordering, contiguous with, or neighboring another WOUS nor is this aquatic resource separated from another WOUS by manmade dikes, barriers, or berms. The closest NHD tributary is approximately 4400 feet to the southeast of W-1, though there is also a canal ditch 2400 feet to the northwest.

The wetland located within the review area does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Furthermore, this wetland is hydologically isolated with no surface or shallow subsurface connectons to a water of the United States and does not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that W-1 is not regulated by the Corps under Section 404 of the Clean Water Act.
