Wetland 1	.32	acre(s)	(b)(1) Non-adjacent wetland.	The wetland does not abut at least one point or side of, a paragraph (a)(1)-(3) water. Based on the USGS, aerial maps, and elevation contours it would not be flooded by an (a)(1)-(3) water in a typical year. The NHD and USGS identify a tributary 0.44 mile away to the southeast of the wetland. Dryland separates the wetland from the tributary. There is no evidence of flow or a tributary on the aerial photographs, NHD and USGS data, or NWI maps adjacent to this wetland. Based on this information, the wetland is not abutting or adjacent to a jurisdictional tributary. Based on this review, the feature is a non-adjacent wetland under the Navigable Water Protection Rule (NWPR), and the assessed feature is not jurisdictional under NWPR and the Clean Water Act.
