- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains 10 wetlands (w-a-001, w-a-019, w-a-020, w-a-022, w-a-023, w-a-024, w-a-025, w-a-026, w-a-027, w-b-057) totaling 1.13 acres that were the result of excavation in dry land for the purpose of obtaining fill, sand, or gravel. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219 published November 13, 1986 (page 41217), states "For clarification, it should be noted that we generally do not consider the following waters to be "Waters of the United States.... (e) Waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of Waters of the U.S." Historic aerial imagery shows that the review area was upland prior to the excavation activity. Therefore wetlands w-a-001, w-a-019, w-a-020, w-a-022, w-a-023, w-a-024, w-a-025, w-a-026, w-a-027, w-b-057 are not considered to be waters of the U.S. and are not jurisdictional under section 404 of the Clean Water Act.**

The review area contains 9 wetlands (w-a-002, w-a-005, w-a-006, w-a-009, w-a-010, w-a-014, w-a-015, w-a-017, w-a-018) totaling 2.19 acres that are completely surrounded by upland with no surface connections to other aquatic resources. Therefore wetlands w-a-002, w-a-005, w-a-006, w-a-009, w-a-010, w-a-014, w-a-015, w-a-017, w-a-018 are not considered to be waters of the U.S. and are not jurisdictional under section 404 of the Clean Water Act.

The Snake River has a well documented history as a waterbody used in the past for interstate and foreign commerce during the fur trade and The Snake River Fur Post.

Summarize rationale supporting conclusion that wetland is “adjacent”: Wetlands w-a-004, w-a-016 and w-c-z are portions of a several thousand acre wetland complex that directly abuts the Snake River.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
