Wetland 3	0.08	acre(s)	(b)(1) Non-adjacent wetland.	<p>The wetland delineation shows Wetland 3 is surrounded by uplands and is not abutting an a(1)-a(3) water with no man made structure bordering the wetlands that would separate them from any tributary. There is a road west of the wetland boundary but there is upland separating from the road and the wetland. There is also no culvert structure that directly connects wetland 3 to the west side of the road. A impounded stormwater pond exists on the west side of the road, but there is no culvert connection from Wetland 3 to that pond. Culverts are seen in area photos that empty into the pond in the vicinity of the review area, but appear to be stormwater outlets associated with the curb/gutter roadway.</p> <p>The nearest mapped tributary is located approximately 1,200 ft. west of the project area and appears to be previously impounded for stormwater purposes. This pond extends to the western side of the adjacent roadway. There is no natural feature separating these features.</p> <p>There is no mapped flood zone for the nearest tributary. The change in elevation (approximately 4 ft) and presence of a large road grade conclude that the tributary would not flood the wetland in a typical year.</p>
