Explain: **The review area contains four wetlands, labeled Wetland Area 5 (0.11 acre), 6 (0.18 acre), 8 (0.03 acre), and 9 (0.04 acre). All of the wetlands are isolated farmed wetlands per review of the June 2019 wetland delineation report by Cedar Corporation, which included USGS topography, NRCS hydric soils map, Wisconsin Wetland Inventory, National Wetland Inventory, Calumet County 2-ft contours, aerial photos, and ground level site photos. All of the wetlands are within and surrounded by non-hydric soils in a regularly farmed field with no inlets/outlets or surface or shallow subsurface connections to a downstream water. The nearest tributary is unnamed to the Fox River, approximately 0.75 mile to the southeast of Wetland Area 9.**

These wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes, or berms. Due to existing and surrounding land use (agricultural fields) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetland Areas 5, 6, 8, and 9 are not regulated by the Corps under Section 404 of the Clean Water Act.
