 - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Wetlands 3, 4, and 5 do not have a surface or subsurface connection to a water of the United States. The wetlands are within moderate depressions with no outlets. The wetlands were determined to be geographically isolated. No surface connections are present between these wetlands and any other waters. Desktop resources such as aerial photography, LiDAR derived elevation models and contours, and stream and wetland, were reviewed and we determined that there are no surface or subsurface connections between these wetlands and other waters.

Wetland 3 (2.86 acres on-site), Wetland 4 (1.91 acres), and Wetland 5 (0.65 acre on-site) do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. These wetlands do not have an ecological connection to other waters within or adjacent to the review area. The wetlands were determined to not be jurisdictional under the CWA because the wetlands lacked links to interstate commerce sufficient to serve as a basis for jurisdiction.
