Wetland A	1.25	acre(s)	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater	Wetland A is a stormwater management pond that was constructed in approximately the year 2000 in an upland area as part of the Flanders Pond Industrial Park. This was confirmed by reviewing historic aerial photos spanning 1938-2020, a wetland delineation that was completed for the project site in 1999 prior to park construction, and construction plans provided for the industrial park. Wetland A is a non-jurisdictional excluded (b)(10) water as described in the Navigable Waters Protection Rule.
