- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The review area includes a 55.6-acre site in Troy Township, Minnesota. The property is currently used for agricultural production. No NWI mapped wetlands are found within the review area. Eight suspect wetland areas were identified during the off-site hydrology review which looked at 12 different aerial photographs between 1992 and 2017. A field delineation was conducted on November 4, 2020 and May 03, 2021 Westwood sampled 6 of the 8 suspect areas. Four of the suspect areas were found to be located on convex hilltops with well-drained, sandy soils; two additional suspect areas were located in depressions that had functioning drain tile inlets. No aquatic resources were found during the field investigations. Therefore, the review area is composed entirely of dry land.
