It is located in a depressional area surrounded by a residential community with no perennial or intermittent surface water connection to a downstream water. The closest tributary shown on the USGS Topographic map is Credit River located approximately 2,000 feet to the east. There is no evidence that the wetland is directly abutting an(a)(1) –(a)(3) water. Wetland 1 was determined to be hydrologically isolated and is therefore not regulated by the Corps under Section 404 of the Clean Water Act.
