Based on a review of aerial photography (from 2005, 2006, 2008, 2010, 2013, 2015, 2017, 2018, and 2020), Waushara County and USGS topo maps, WDNR Surface Water Data Viewer, NRCS Soil Survey, Wisconsin Wetland Inventory, and June 8, 2021 Davel Engineering & Environmental Wetland Delineation, Wetland 1 is surrounded by upland on the north, west, and south sides. Wetland 1 drains easterly outside of the JD review area through an unnamed ditch for approximately 650 feet until the unnamed ditch continues north approximately 200 feet towards a culvert in State Highway 21. Desktop resources used for this JD clearly show that the unnamed ditch is a man-made feature constructed in a combination of mapped uplands and wetlands. A review of all available information indicates the unnamed ditch is not a relocated natural tributary. Accordingly, the unnamed ditch is an excluded water under the NWPR. Based on this information, we have determined that Wetland 1 is an (b)(1) Non-adjacent wetland which is not regulated by the Corps under Section 404 of the Clean Water Act
