Explain: **Wetland 1, located in the review area is an isolated feature and is not considered a Water of the US. Review of aerial photography (Google Earth 1992-2015) indicates the wetland is a depressional feature that developed on the edge of commercial development. The agricultural field in which it is located does periodically show saturated soils and drainage patterns, but a surface or subsurface connection to another water is not present. LiDAR imagery shows the wetland as closed depression. The nearest tributaries are approximately 0.15 mile and 0.34 mile from the wetland feature. No surface water connection can be traced to either of these waterways. Careful consideration was given to a potential flow path to the north. This wetland does not border, is not neighboring to or contiguous with another water of the US. It is not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (agriculture) and proximity to other waters, there is no ecological connection to other wetlands or waters. This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetland 1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
