It is bordered by a road, a senior living facility, and condominiums. Wetland 1 is a shallow marsh wetland basin partially fed by stormwater runoff from a curb cut. Maps showing contour lines, National Wetland Inventory, and National Hydrology Dataset data and aerial imagery indicate this wetland has no surface water connections to jurisdictional waters. Therefore, Wetland 1 does not abut an (a)(1)-(3) water and is not a water of the U.S.
