Explain: **In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following activities to be waters of the United States; water filled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction of excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States. According to the project consultant, construction activities have created waterfilled depressions within Wetlands 3 (0.05 acre), 4 (0.21 acre) and 5 (0.03 acre) as outlined on attached map. Aerial imagery of the review area shows grading and filling of the entire site including the AJD review area beginning in 2005 and can be seen through 2011. Grading activities continued in different areas of the overall project site from 2011 through to the present, demonstrating that construction activity on the overall site is ongoing. Therefore, Wetlands 3, 4 and 5 as shown on the attached map are not a waters of the U.S.**
