While the soils map showed areas mapped as predominantly hydric, current and historic aerial imagery submitted in the delineation report showed no potential wetland areas. I contacted the LGU about the site and he too had no concerns for potential wetlands. Based on the information above, the Corps determined that there are no jurisdictional wetlands on site.
