C. Additional comments to support AJD: [Based upon information gathered as a result of the desktop review and wetland delineation report, Corps staff determined that Wetlands W1A, W1B, W1C, W1D, W1E, and W1F are not waters of the US. The above wetlands drain offsite to the west to a manmade ditch that runs adjacent to the property. This manmade ditch continues south and ultimately south east to Golden Lake which is an \(a\)\(3\) water of the US. The manmade ditch is not a tributary, therefore Wetlands W1A,](#)
