### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

However the boundaries of this current determination have been constricted due to a change in ownership and this feature is no longer included within the review area. Though Barkhausen Creek is no longer within the review area, it has been identified as a perennial tributary on the NHD and a review of aerial photos and numerous staff observations between May and August of past years have all documented flow within the creek; (2) The open water area identified on the map is assumed

to be present year-round based on a review of recent aerial photographs, observations of other open water areas on the property in the vicinity of the review area and on knowledge of regional groundwater levels gained from investigations throughout this portion of Brown County.

Additional desktop investigations utilizing the Wisconsin Wetland Inventory, air photographs, soil maps, and topographic maps all indicate that the wetland extends outside of the review area boundary to Barkhausen Creek southeast of the Davis property. A second hydrologic connection to Barkhausen Creek has also been established via the excavation of an open water area east of Wetland 3. The open water area appears to have a surface outlet in the southeastern corner that flows south toward Barkhausen Creek ultimately following the same pathway as the previously described wetland connection to Barkhausen Creek. A site specific determination was not conducted to verify this information, however, there is sufficient information to conclude that a continuous surface connection to Barkhausen Creek is present. Wetland 4: The wetland delineation provided by the property owner shows the boundary of Wetland 4 extending to the eastern boundary line. Additional desktop investigations utilizing the Wisconsin Wetland Inventory, air photos, soil maps, and topographic maps all indicate that Wetland 4 extends south and somewhat east outside of the review area and merges with Wetland 3 off of the Davis property. As a result, Wetland 4 has a continuous surface connection to Barkhausen Creek.**
