The wetlands abut a road to the south and are otherwise surrounded by upland forest and grassland. This is confirmed by the contour and aerial maps and wetland boundary information submitted by the applicant in the March 27, 2019 joint application. Therefore, the Wetland 1 and Wetland 7 do not abut an a(1)-a(3) water and are not waters of the U.S.
