W-1	2.18	acre(s)	(b)(1) Non-adjacent wetland.	W-1 extends off-site to west, so the larger wetland complex was reviewed. There are three existing outfall structures on the west side of W-1 that direct flow to a man-made stormwater pond on the other side of I-94; however, these outfalls do not lead to a paragraph (a)(1)-(3) water. To the east, the wetland connects to a non-jurisdictional roadside ditch. W-1 does not abut at least one point or side of an (a)(1)-(3) water. Based on the United States Geologic Survey and elevation contours it would not be flooded by an (a)(1)-(3) water in a typical year. There is not a natural berm, bank, dune, or similar natural feature physically separating it from a paragraph (a)(1)-(3) water. It is not physically separated from a paragraph (a)(1)-(3) by an artificial dike, barrier, or similar artificial structure. Therefore, W-1 does not fall under Corps jurisdiction under the NWPR.

These features are ephemeral roadside ditches that were constructed in upland to convey localized water runoff. These six ditches do not relocate a tributary, are not constructed in a tributary, and are not constructed in an adjacent wetland. Therefore, they are excluded as (b)(5) ditches.
