Rationale: The USGS NHD, National Wetland Inventory, and the Minnesota public water inventory did not identify any water feature within the review area. Historical evidence from USGS and aerial photographs indicated this was not a historical feature. The area is comprised entirely of dryland without any aquatic resources on-site.
