	wetlands, of any kind in the entire review area). Rationale: The wetland delineation report provided a
	National Wetland Inventory (NWI) figure that denoted no wetlands within the review area. The National
	Hydrography Dataset (NHD) was also reviewed and showed no surface waters onsite. An aerial photo
	review was also provided, reviewing aerial imagery from 1992, 2003, 2004, 2006, 2008, 2010, and
	2015. The images were reviewed for wetland signatures. Wet signatures were found in 28% (2 of 7) or
	historic aerial images. This supports that the area does not have a wetland onsite. Based on this
	information, the review area is not jurisdictional due to the absences of a water of the U.S.
