There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined not to be jurisdictional. Explain: The review area contains 5 wetlands, labeled Wetland Area 1, Wetland Area 2, Wetland Area 3, Wetland Area 4, and Wetland Area 5 on the attached figure MVP-2018-02916-AIS Page 2 of 5. Soils within the areas in question consist of Wainola loamy fine sand, Rousseau loamy fine sand, and Hortonville silt loam. According to Natural Resources Conservation Service (NRCS), these soil units are predominantly non-hydric. Historical aerial imagery supports the determination that Wetland Area 4 is a settling basin constructed in uplands between 2006 and 2008. The basis for this jurisdictional determination is the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps generally does not consider certain waterbodies to be Waters of the U.S. (WOUS), including: Artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing. Therefore, Wetland Area 4 is not a WOUS and are not jurisdictional under the CWA.

In their current state, Wetlands 1, 2, 3, and 5 are not connected to tributaries. These wetlands are not bordering, contiguous with, or neighboring another WOUS nor are these aquatic resources separated from another WOUS by man-made dikes, barriers, or berms. The wetlands located within the review area do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Furthermore, these wetlands are hydrologically isolated with no surface or shallow subsurface connections to a water of the United States and do not have an ecological interconnection due to existing disturbance. Therefore, the Corps has determined that Wetland Area 1, Wetland Area 2, Wetland Area 3, and Wetland Area 5 are not regulated by the Corps under Section 404 of the Clean Water Act.
