A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no “*navigable waters of the U.S.*” within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Explain: **The review area contains two aquatic features, Wetland 2 and Wetland 10, as shown on the attached figure labeled MVP-2022-00873-RJH: Page 2 of 2. Based on a review of historic aerial photography, topographic maps, LiDar, DEM, and the wetland delineation report submitted by the requestor, we have determined that Wetlands 2 & 10 are isolated depressions with boundaries that transition into uplands. As depicted in aerial imagery, the wetland signatures observed within the delineated features do not extend outside of the delineated wetlands and are surrounded by uplands. In addition, no confined aquatic connections to other resources are identified.**

Wetland 2 & 10 do not abut and are not separated from any waters of the U.S. by natural or man-made features. The nearest mapped aquatic resource is an unnamed tributary to Lake Winnebago located approximately 75 feet west of Wetland 2 and 230 feet south of Wetland 10. Historical aerial photography depicts minor wet signatures in the immediate areas. However, no surface water or ecological connections are present that links these wetlands to the tributary or other aquatic resources. Based on this information, the wetlands within the review area are ecologically separated from all other aquatic resources.

Wetland 2 & 10 do not support a link to interstate foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined these two aquatic feature are not regulated by the Corps under Section 404 of the Clean Water Act.
