Wetland 1	5.07	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 1 in the review area is part of a larger wetland system that extends northeasterly onto neighboring lands. The entire wetland system extends easterly towards an unnamed tributary to Token Creek, however, approximately 2,500 linear feet of mapped uplands eliminates a direct hydrologic surface connection between the wetland system and the unnamed tributary to Token Creek during a typical year. Wetland 1 does not meet the NWPR definition of adjacency.
