Wetlands 1-4	1.75	acre(s)	(b)(1) Non-adjacent wetland.	<p>Wetlands 1-3 are three separate isolated wetland basins located in depressional areas on the north side of Trunk Highway (TH) 371B. All three wetlands are surrounded by uplands and non-jurisdictional ditches and do not have a direct hydrologic surface connection to downstream waters.</p> <p>Wetland 4 is a small wetland located on the south side of TH 371B between the highway and frontage road. The wetland is surrounded by uplands along the highway and is physically separated from a larger wetland basin to the south by the frontage road. There is no evidence of a culvert on the frontage road that separates Wetland 4 from the larger wetland basin to the south, therefore, Wetland 4 does not have a direct hydrologic surface connection to downstream waters.</p> <p>This was documented in the delineation that was completed for the project site and confirmed by reviewing the enclosed national wetland inventory and topographic mapping for the project site. The assessed wetlands do not abut jurisdictional waters, are not inundated by flooding from a traditional navigable water, or tributary, or from a jurisdictional lake, pond, or impoundment, and are not physically separated from a jurisdictional water by only a natural feature or artificial structure that allows for a direct hydrologic surface connection. Based on this review, the assessed wetlands are not jurisdictional under the Navigable Waters Protection Rule (NWPR) because they meet the requirements of the exclusion for non-adjacent wetlands under paragraph (b)(1).</p>
Linear Ditch 1-9	2.23	acre(s)	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of	Linear Ditch 1-9 were constructed in uplands to convey runoff from TH 371B and are now linear wetlands that meet the definition of “ditch” under paragraph (c)(2). In addition, the ditches are not

⁴ Some excluded waters, such as (b)(2) and (b)(4), may not be specifically identified on the AJD form unless a requestor specifically asks a Corps district to do so. Corps districts may, in case-by-case instances, choose to identify some or all of these waters within the review area.

⁵ Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

(a)(1) waters, are not relocated tributaries, are not constructed in a tributary, and are not constructed in an adjacent wetland. This was confirmed by reviewing aerial photography, national wetland and hydrography data, and the wetland delineation report. Based on this review, the assessed ditches are not jurisdictional under the NWPR because they meet the requirements of the exclusion for ditches under paragraph (b)(5).
