The area where Wetland 1 was constructed lacked wet soil indicators and sufficient hydrology to support wetland conditions prior to construction and it is not part of a relocated tributary. Therefore, this wetland was constructed in uplands. The review area is situated within a predominantly non-hydric soil series (OnB). Based on the topography and geometry of the review area, the boundaries of this feature transition into upland areas within the review area and these wetlands are confined to the toe slope of the constructed ditch.</p> <p>Based on the information stated above, we have determined that Wetland a is a (b)(5) excluded water and is therefore not regulated by the Corps of Engineers under Section 404 of the Clean Water Act.</p>
