			Based on aerial photos, soil maps, topographic maps, and Wisconsin Wetland Inventory, Wetland 1 is a small wet depression between two farm fields and surrounded by upland. There are no inlets/outlets other than overland sheet flow. The nearest tributary is Bark River, approximately 1,400 feet to the west and over 10 feet lower in elevation (850' to 860'). According to the National Flood Hazard Layer, the wetland is in the zone of minimal flooding. Therefore, W-1 would not be flooded by an (a)(1)-(a)(3) water in a typical year. There are no natural or artificial structures separating W-1 from an (a)(1)-(a)(3) tributary.
