Wetland 2, 3	0.74	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 2 and 3 are seasonally flooded basins on a site with a mix of croplands, woodland, wetland, and lake. Wetland 2 is partially off-site and adjacent to cropland and forest. Wetland 3 occurs entirely on site and within the cropland area. An upland drainageway drains Wetland 3 into Wetland 3A, but the drainageway is not a wetland or stream. The delineation, contour lines, aerial photography, NWI map, and the National Hydrography Dataset map show no natural and direct surface water connections for Wetlands 2 or 3. Therefore Wetlands 2 and 3 do not abut an (a)(1)-(3) water and are not waters of the U.S.
