☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains two wetlands, W-1 (2,250 square feet) and W-2 (a and b- 2,057 sf).**

Wetland 1 was constructed in upland sometime between 2000-2005 and was designed as a stormwater ditch. The ditch carries stormwater runoff north through a culvert to an off-site stormwater pond, and it does not carry perennial flow. Wetland 2 (a and b) is a roadside ditch constructed in upland that does not carry perennial flow. Both of these ditches are draining only upland. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following waters to be waters of the United States; non-tidal drainage ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in *Rapanos v. U.S.* and *Carabell v. U.S.* issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States.
