Explain: The review area contains 2 aquatic features: Wetland 3 (1.25 acres) and Wetland 4 (0.02 acre). Wetland 3 was constructed in uplands for the purpose of stormwater management associated with a commercial facility. This feature is not a water of the US. The jurisdictional determination for this feature is in accordance with the pre-amble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps does not generally consider the following to be waters of the US; artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing.

Based on information provided in a recent wetland delineation report, the Corps has determined that the ditch identified as Wetland 4 within the review area shown on MVP-2019-01469-RJH Figures 1 of 2 through 2 of 2 was excavated wholly in and drain dry land only. Additionally, it has been determined that the subject ditch does not have relativley permanent flow. In accordance with the Corps/EPA Memorandum Regarding CWA Jurisdiction Following Rapanos, Wetland 4 is not a water of the United States.
