## SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

#### B. CWA SECTION 404 DETERMINATION OF JURISDICTION.

There are no "waters of the U.S." within Clean Water Act (CWA) jurisdiction (as defined by 33 CFR part 328) in the review area.

  - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: This AJD is limited to the boundaries of Wetland 2, as shown on the attached figures labeled MVP-2022-01503-SSC, Pages 1-2 of 2. Based on the wetland delineation report submitted by the requestor, aerial imagery, and LiDAR contours, we have determined that the wetland is isolated with boundaries that transition to uplands.

Wetland 2 is a shallow marsh wetland with fresh wet meadow fringe located near the northwest boundary of the site. The wetland is surrounded by upland, as shown on 2-foot LiDAR contours submitted by the requestor. Review of historic USGS topographic maps, the National Wetland Inventory (NWI), and National Hydrography Dataset (NHD) do not show a surface water connection to a Water of the U.S (WOTUS). Additionally, available aerial imgery was reviewed during leaf-off conditions and does not show a surface water connection to a WOTUS.

Wetland 2 does not support links to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. This wetland does not have an ecological connection to a WoUS. Furthermore, the area is hydrologically isolated with no surface water connections to a WoUS. Therefore, the Corps has determined that Wetland 2 is not regulated by the Corps under Section 404 of the Clean Water Act.
