Wetland 1	1.40	acre(s)	(b)(1) Non-adjacent wetland.	This determination is for Wetland 1 in the approximately 2-acre review area as shown on MVP-2021-00317-KDZ, Figure 1. Based on a review of the Wisconsin Wetland Inventory, USGS Topographic Map, USDA-NRCS Soil Survey, and January 2019 Taylor Conservation, LLC Wetland Delineation Report, Wetland 1 is in part of a larger wetland system that extends south and east towards a man-made drainage ditch. The man-made drainage ditch was not constructed in an adjacent wetland, exhibits ephemeral flow during a typical year and is not a relocated natural tributary. Accordingly, the man-made drainage ditch is not a tributary under the NWPR and Wetland 1 does not meet the NWPR definition of adjacency.
