Wetland A	0.055	acre(s)	(b)(1) Non-adjacent wetland.	Wetland A does not abut at least one point or side of a paragraph (a)(1)-(3) water. Based on the United States Geologic Survey and elevation contours it would not be flooded by an (a)(1)-(3) water in a typical year. There is not a natural berm, bank, dune, or similar natural feature physically separating it from a paragraph (a)(1)-(3) water. It is not physically separated from a paragraph (a)(1)-(3) by an artificial dike, barrier, or similar artificial structure. The only outlet from Wetland A is through overland sheet flow. Therefore, this wetland does not fall under Corps jurisdiction under the NWPR.
Wetland C	0.662	acre(s)	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	Wetland C was constructed in upland in 1991 as a dry stormwater detention basin. Historical topo maps as far back as 1892 show the area was just north of mapped wetlands. No wet signatures were present in 75% of the aerial photographs reviewed for the years 1937, 1963, 1967, 1970, 1975, 1980, 1985, and 1990. A plat of survey from 1991 depicts the wetland as a detention basin. The soils are non-hydric by common indicators. Stormwater control features constructed or excavated in upland or in non-jurisdictional waters to convey, treat, infiltrate, or store stormwater runoff are excluded from waters of the United States. Therefore, this wetland does not fall under Corps jurisdiction under the NWPR.
