Explain: **The review area contains one aquatic resource (labeled as Wetland 1 on Figures) that is an isolated depression with no surface or shallow subsurface connection to any waters of the U.S. including the nearest aquatic resource which is an unnamed tributary to the Manitowoc River located approximately 0.21 mile to the east. This wetland does not border, neighbor, nor is contiguous with another water of the U.S. It is not separated from other waters of the United States (WOUS) by man-made dikes, barriers, or berms. The surrounding land use consists primarily of wooded areas, residential development, and a paved roadway to the north and east. Due to it's size, Wetland 1 provides limited habitat functions to WOUS and surrounding areas and provides no ecological connection.**

This aquatic resource does not support a link to interstate foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined this aquatic feature is not regulated by the Corps under Section 404 of the Clean Water Act.
