SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

B. CWA SECTION 404 DETERMINATION OF JURISDICTION.

There are no"waters of the U.S." within Clean Water Act (CWA) jurisdiction (as defined by 33 CFR part 328) in the review area.

2. Non-regulated waters/wetlands (check if applicable):1

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area includes one wetland, labeled Wetland 1 (0.08 acre). This wetland is isolated based on a review of the August 2022 Hey and Associates, Inc. delineation report and other materials, including USGS soils, National and WI State Wetland Inventory, WI DNR DEM and Hillshade, Google Earth aerial photos, and historic aerial imagery. Based on the delineation report and topographic contours, this wetland is located within a drainage feature in an upland setting and does not have any inlets or outlets. There are no surface or shallow subsurface connections to downstream waters, confirmed by reviewing the abovementioned resources.

Wetland 1 is a farmed wetland that sits in an agricultural field. The wetland collects water from surrounding uplands during precipitation events. It is a depressional wetland with boundaries that transition into uplands. W-1 sits in a concave depression with elevation sloping up on the north, south, and east and northwest boundaries. Topography gradually slopes to the southwest, but no discrete connections to other waters exist. This is evident while viewing WI DNR DEM and hillshade layers.

The wetland does not border, is not neighboring to or contiguous with another water of the US. It is not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (disturbed upland in commercial, residential, and agricultural use) and proximity to other waters, there are no ecological connections to other wetlands or waters. This aquatic resource does not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetland 1 is not regulated by the Corps under Section 404 of the Clean Water Act.
