The site photos clearly show a water control structure and constructed berm around the ponds. The ponds were constructed sometime between 1993-1997 for a subdivision expansion, based on a 1995 aerial photo showing the site being graded. The sloping topography of the area, the predominately non-hydric soil type, and the lack of historic aerial photos showing wet signatures all indicate that, prior to construction, the site would not have formed hydric soil inclusions or had other wetland characteristics. Therefore, the ponds were constructed in upland. |
