W-1	6.5	acre(s)	(b)(1) Non-adjacent wetland.	W-1 does not abut at least one point or side of a paragraph (a)(1)-(3) water. Based on the Unites States Geologic Survey and elevation contours it would not be flooded by an (a)(1)-(3) water in a typical year. There is not a natural berm, bank, dune, or similar natural feature physically separating it from a paragraph (a)(1)-(3) water. A road (artificial barrier) on the north end of the review area separates W-1 from a wetland north of the road, however, this wetland is not an (a)(4) water and there is also not a surface water connection between these two features in a typical year. The only outlet from W-1 is through overland sheet flow. Therefore, W-1 does not fall under Corps jurisdiction under the NWPR.
